Website Improvements

- Continue improvements to our memorization paper creation software to make it easier for organizers to generate and print papers, as well as for competitors to customize lines and partitions on papers.
- Standardizing competition and registration web pages for all competitions is another important step as we go forward. A competitor must be able to consistently register for all IAM competitions with a common interface and all such data must be logged on directly to our database.
- Add option to competition software to store results and give rankings in training mode

Easier Access around the Globe

- Continue adding data to training software for many more languages.
- Work with more organizers in more countries to give easier access to memory sports competitions to everyone. I would be personally willing to travel to new countries in my continent as necessary for the same.
- Adding multilingual support/translations to our website to increase accessibility by a much wider audience

FAQs and Tutorials on our website

- Providing new users easier access to searching past and future competitions in their country. In the current form, it can be difficult for new users to get started.
- Having dedicated FAQs, written and video tutorials pages for both memory athletes as well as competition organizers will help in much easier and standardized on-boarding for new people to IAM competitions.

Live Results System

• Currently, excel is used in most places to track results of a competition and then make announcements or share snapshots manually. With a live results website system, an organizer can enter event results in an excel like sheet but the results get broadcast to anyone in the world, on their mobile phone or PC.

Promoting Digital Competitions

- At the moment, very less competitors have competed digitally. However, most competitors who have used the format for a small duration agree on the benefits to both the scores, as well as the organizing side of things.
- I would seek to promote digital competitions actively in more parts of the world, coupled with my vision for easier access to competitions around the globe.
